Meeting called to order at 7:02

Last months minutes were approved. Mary motioned, Jenna seconded.

Treasurers report- \$3700.

John suggested that we have a 2 day in march 3rd-4th instead and if it gets rained out add it to the 2 day in april. Then if both those get rained out we will make a 2 day in september. Jenna motioned the show dates and liz seconds. Voted and passed. Kathy suggested we change the september shows to the 16th because some of the kids might be at state during the 9th show. Kathy motioned that we change the september show. Donna seconded. Voted, passed.

New show dates- March 3rd-4th optional april 1st, May 5th-6th, June 3rd, July 7th-8th, September 15th-16th.

Liz suggested to talk to the Greenbank farm to put in a arena there. Greenbank farm would love for more equestrian traffic up there. Need to figure out what has to be done to put one in. Money? Work? Maybe need to have a committee to head this up and figure out the details. John motioned that we make committee to look into all the info for this.

Jenna motion that we pay the \$50 online and take care of it now. Liz seconded. Voted, passed.

Commitees- We need to have some people for O-Mok-See, upstairs, advertising and parties and Judging. Jenna will head up the upstairs committee to figure it all out. Nicholle said she will be on the advertising committee, next year we need to make sure we our name out there more.

Jenna suggested for next-year we use numbers to help the computer person or Kristi suggest we make a list and thats where you ride all day. With the numbers you would have to have a gate person calling out numbers. Tabled to next meeting.
